BETWEEN

Hiralal Bhakat College established in 1986, is a government-aided general degree college West Bengal, India. The college offers undergraduate degree courses in arts, science, and commerce. The College is affiliated with the University of Burdwan and is also recognized by the University Grants Commission(UGC).

AND

Fragrant Creation (UDYAM-WB-10-0027858)

Fragrant Creation is a proprietorship, and micro enterprise, represented by acclaimed filmmaker and director Sourav Sarkar, conducting film – production (making), film – exhibition, film – analysis and academic sensitization on films, serving interdisciplinary connection between film medium and various fields of study and research in social sciences.

1. Purpose of the MoU

The **Hiralal Bhakat College** and the **Fragrant Creation** intend to develop cooperation and collaboration in research for development, training, joint diploma/certificate programs/courses, and other agreed activities that further the aims and objectives of the Institutions as follows:

- a) To organize and conduct seminars, conferences, workshops, certificate courses, value added courses, certificate courses, add – on courses pertaining to film – medium and film making (analysis and development of technical skill) in collaboration, subject to the availability of funds.

2. Major Objectives/ Scope of the MoU

- a) Fragrant Creation, in collaboration with Hiralal Bhakat College , may arrange for joint workshops/training/seminars/conferences/certificate courses/ value added courses/ add – on courses etc. The location for the said programmes and the participating charges may be defined upon mutual consent. However, the number of committed students for each workshop or certificate course or value-added course, should be decided mutually on a prior basis.
- b) HIRALAL BHAKAT COLLEGE and Fragrant Creation will jointly promote the activity that would be conducted. The participants should be the students and academic members under the aegis of Hiralal Bhakat College.

3. Future Objectives/Prospect of the MoU

1. Research collaboration on film medium/ Value Added Course/ Certificate Course/ Grant Writing Support on film medium/Publication & short film production/ Book Chapter Writing in relation to film medium /Faculty Development Programs. These can be an obvious consequence of long-term association between both parties.

4. Understanding between the two Parties

- a) Both parties acknowledge the need to create an ecosystem for promoting innovation and entrepreneurship and are interested in partnering to further this cause.
- b) There is a need to inculcate an entrepreneurial & problem-solving mindset among the students and youth.
- c) Both parties will work on applying and conducting various government skill development projects for the benefit of a wide spectrum of students.

4. non-exclusivity

The relationship of the parties under this MOU shall be non-exclusive and both the parties, including their affiliates, subsidiaries, and divisions, are free to pursue other agreements or collaborations of any kind.

5. Termination of MoU

This MOU commences from the date of the last signing and shall be in force for 3 years. The MOU may be terminated at any time by mutual consent or by 6 months' notice by either party. It may be amended, modified, extended, or renewed only by the written consent of both Parties. The Institutions agree to review this MOU six months prior to the end of the 3-year term.

6. Confidentiality

- a) The parties to this MoU undertake to treat as CONFIDENTIAL AND PRIVILEGED information of either party. The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.
- b) Except as reasonably required, both the parties covenant that neither the party shall at any time during this MOU or at any time after it is terminated disclose or reveal to any person/organization or otherwise make use of confidential information including any of the trade secrets, confidential operations, processes or dealings or any information concerning the parties and their subsidiaries, business, finances, transactions or affairs of the affiliates/agencies or any of their ventures which may come to the knowledge of either the party during the period.
- c) During the period of the MOU, each party agrees to respect each other's freedom of operation. Neither the parties shall interfere in the affairs/functioning of the other.

7. This MOU is not intended to create any legally binding obligations nor any financial commitment on either institution but, rather, is intended to facilitate discussions regarding general areas of cooperation as stated above, and the financial liabilities / workshop - fees / course - fees regarding the certificate courses or value-added courses for the students may be decided upon a basis of mutual understanding and cooperation. Hiralal Bhakat College will solely be able to collect reasonable monetary subscription as per the discretion of the College, from the participating members in such Value Added Course / Certificate Course. Hiralal Bhakat College will negotiate the per hour fees payable to Fragrant Creation from the Hiralal Bhakat College, in case of the value added course / certificate course conducted.
